THE MISSION OF THE KOREA DEFENSE VETERANS ASSOCIATION (KDVA) IS TO ENHANCE THE REPUBLIC OF KOREA-UNITED STATES ALLIANCE BY ADVOCATING FOR THE ALLIANCE AND SUPPORT THE PEOPLE WHO BUILT AND SERVE THE ALLIANCE. KDVA MEMBERSHIP PROGRAMS AND ACTIVITIES DRAW PEOPLE TO JOIN KDVA TO SUPPORT THE ROK-U.S. ALLIANCE AND OUR VETERANS AND INCLUDE MEMBERSHIP DRIVES AND MEMBERSHIP MATERIALS. KDVA CONDUCTS WEBINARS AND HYBRID ON-SITE/WEBINAR EVENTS, MANY WITH NEW PARTNER ORGANIZATIONS, TO PROVIDE OUR VIRTUAL AND ON-SITE AUDIENCES OPPORTUNITIES TO INTERACT WITH KDVA MEMBERS AND LEADERS. EVENTS ARE NORMALLY HOSTED IN ENGLISH AND KOREAN.

II. CURRENT YEAR FACTS AND CIRCUMSTANCES:

ATTRACTION OF AND SOURCES OF SUPPORT KDVA IS PRIMARILY FUNDED THROUGH LARGE CONTRIBUTIONS FROM ORGANIZATIONS WITH SIMILAR MISSIONS AND INTERESTS TO KDVA. WHILE THESE ORGANIZATIONS ARE PRIMARILY BASED IN THE REPUBLIC OF KOREA (ROK) AND THUS DO NOT HAVE PUBLIC CHARITY STATUS IN THE UNITED STATES, THEY GENERALLY RAISE FUNDS FROM MANY DIFFERENT SOURCES AND OPERATE SIMILARLY TO MANY PUBLIC CHARITIES IN THE UNITED STATES. KDVA'S DIRECT FUNDRAISING FROM THE GENERAL PUBLIC IS PRIMARILY THROUGH ITS INTERACTIONS WITH ITS MEMBER BASE ACROSS THE UNITED STATES AND OTHERS AT ITS EDUCATIONAL EVENTS, THROUGH ITS PARTNERSHIPS WITH OTHER ORGANIZATIONS WITH SIMILAR MISSIONS, AND, TO A LESSER EXTENT, THROUGH WEBSITE DONATIONS. KDVA INITIALLY RELIED MORE HEAVILY ON CONTRIBUTIONS FROM ITS LARGE DONORS AS A NECESSITY WHEN ITS OPERATIONS WERE STARTING UP, AND THAT CONTINUED DURING THE COVID PANDEMIC WHEN PUBLIC EVENTS AND RELATED FUNDRAISING WERE NOT VIABLE OPTIONS. KDVA EXPECTS TO SIGNIFICANTLY DIVERSIFY ITS FUNDING IN THE COMING YEARS THROUGH AN EXPANSION OF ITS FUNDRAISING EFFORTS, AND ORGANICALLY THROUGH THE GROWTH OF ITS MEMBERSHIP BASE, WHICH INCREASED BY 150% IN 2024, INCLUDING TOPPING OUR FIRST 25,000 MEMBERS. KDVA DOES NOT RECEIVE A SUBSTANTIAL PORTION OF ITS FUNDING FROM ANY SINGLE INDIVIDUAL OR FAMILY AND DOES NOT EXPECT TO DO SO IN THE FUTURE. GOVERNING BODY KDVA HAS A DIVERSE GOVERNING BODY (BOARD OF DIRECTORS), WHICH IS CURRENTLY COMPRISED OF 12 INDIVIDUALS WITHOUT ANY FAMILIAL RELATIONSHIPS AMONG THEM. MOST OF THE GOVERNING BODY MEMBERS HAVE MILITARY BACKGROUNDS IN THE UNITED STATES OR KOREA AND HAVE AN IN DEPTH UNDERSTANDING OF THE U.S.ROK ALLIANCE, WHICH IS USEFUL IN DEVELOPING KDVA'S PROGRAMS AND MATERIALS USED TO EDUCATE THE GENERAL PUBLIC.

WHILE KDVA DOES HAVE FOUR MEMBERS OF ITS GOVERNING BODY WHO ARE BOARD MEMBERS OF ORGANIZATIONS THAT MAKE SIGNIFICANT CONTRIBUTORS TO KDVA, THOSE MEMBERS HAVE RIGHTS CONSISTENT WITH OTHER MEMBERS OF THE BOARD AND REPRESENT ONLY 25% OF THE VOTING RIGHTS. (TWO OF THESE BOARD MEMBERS COMPLETED THEIR TERMS ON JANUARY 31, 2023.) PUBLIC PARTICIPATION IN PROGRAMS AND POLICIES KDVA PRIMARILY DISSEMINATES INFORMATION THROUGH SOCIAL MEDIA, MEMBERSHIP AND SIMILAR EVENTS, AND MEMBER WORD OF MOUTH. KDVA ALLOWS ANYONE WITH AN INTEREST IN THE U.S. ROK ALLIANCE TO BECOME A MEMBER WITHOUT PAYING ANY MEMBERSHIP FEE, AND ALL ITS MEMBERS HAVE ACCESS TO THE EDUCATIONAL MATERIALS DEVELOPED BY KDVA.

KDVA HAS THE CHARACTERISTICS OF A "PUBLICLY SUPPORTED" ORGANIZATION, BASED ON THE FACTS AND CIRCUMSTANCES TEST DESCRIBED IN SECTION 1170A-9(E)(3) OF THE TREASURY REGULATIONS SPECIFICALLY, A SMALL NUMBER OF DONORS DO NOT CONTROL KDVA, RATHER KDVA IS A GROWING INSTITUTION THAT BEARS MANY OF THE INDICIA OF A "PUBLICLY SUPPORTED" ORGANIZATION, INCLUDING PUBLIC SUPPORT FROM A WIDE CROSS-SECTION OF MEMBERS, WITH A REPRESENTATIVE GOVERNING BODY. MOREOVER, KDVA IS CONTINUING TO SEEK NEW SOURCES OF SUPPORT FROM THE GENERAL PUBLIC AS WELL AS OTHER ORGANIZATIONS ACCORDINGLY, KDVA QUALIFIES AS A "PUBLICLY SUPPORTED" ORGANIZATION DESCRIBED IN SECTION 170(B)(1)(A)(VI).
